## PERMIT CONDITIONS AND REQUIREMENTS

All permit applications must be submitted with payment and a drawing of the irrigation system with property lines and buildings shown.

**Permit must be acquired BEFORE any installation.** Failure to get permit will result in a **\$500 fine!**

1. The drawing must show owners name and the address of the installation.
2. The drawing must show where access to the owner's service line is (actually) cut in.
3. The cut in must be a minimum of three (3) feet from all LKSUD meter boxes or valves.
4. No irrigation valves, heads, wiring, or control boxes shall be put into any easement.
5. The cost of the permit includes a Customer Service Inspection of the irrigation installation.
6. The RPZ backflow device must be inspected upon installation and reported to our online submission service with 10 days.
7. The owner is aware that all required RPZ backflow devices are to be inspected and reported annually by a licensed professional.
