This Notice of rate adjustment is being made in accordance with our Rate Order under Section B, 6.

The Lake Kiowa Special Utility District Board of Directors at the meeting on November 12, 2025, adopted Ordinance 2025-002, Appendix B with the following residential rate adjustments to become effective for usage beginning **January 1, 2026**:
